**RESPONDENT CRESCI** moves this Court for continuance of this case from the Court's January 27, 2023 calendar, and states that this motion for Continuance is made for the following reasons, and for good cause shown:

- 1. This is an action for reciprocal discipline for a January 27, 2023 return date. Respondent Cresci has been in contact with Amanda M. Kates, Esquire, Assistant Disciplinary Counsel, State Bar of Texas. Ms. Kates has professionally agreed to the Request for Continuance-as it is our first request.
- 2. The Court has set the cause for a return date of January 27, 2023. We are requesting a Continuance of thirty (30) days to respond and provide materials, documents, and evidence. Respondent Cresci has been a licensed Texas Attorney since 1998.

- 4. The Request for Continuance will not prejudice the State Bar of Texas, as justice must be done. As aforementioned, Ms. Kates agreed to the Continuance, and does not oppose such a

request. Respondent Cresci would suffer prejudice if these matters are not addressed; a license is a property right subject to due process.

- 5. Justice will be best served if the Court continues this action. BODA will retain control of its own docket and insure this matter proceeds in an orderly fashion.
- 6. This Request for Continuance will not unduly inconvenience the Court because the BODA (Board of Disciplinary Appeals) addresses the docket on a quarterly basis

WHEREFORE, Respondent Cresci respectfully requests that the Court continue deadline of this matter for a period of thirty (30) days, OR to the next available calendar in April 2023.
