COMES NOW, the Commission for Lawyer Discipline, Petitioner, and files this Unopposed Motion for Continuance.

Introduction

- Petitioner is the Commission for Lawyer Discipline, a committee of the State Bar of Texas.
 Respondent is William O. Grimsinger, State Bar No. 00792151.
- 2. The Petition for Probation Revocation was filed on October 2, 2023, asking this Board to Revoke Respondent's currently probated suspension.
- Respondent was personally served with the Petition for Revocation of Probation on October 3,

7. Petitioner therefore requests a continuance in order to allow for Petitioner's witness to be

present to testify.

For these reasons, Petitioner asks the Board to GRANT the motion for continuance. The continuance is not sought for delay only, but that justice may be done.


