AGREED JUDGMENT OF PUBLIC REPRIMAND

On the 27th day of February, 2004, the above-styled and numbered reciprocal disciplinary action was called for hearing before the Board of Disciplinary Appeals. Petitioner appeared by attorney and Respondent appeared pro se as indicated by their respective signatures below and announced that they agree to the findings of fact, conclusions of law and orders set forth below. The Board of Disciplinary Appeals, having reviewed the file and in consideration of the agreement of the parties, is of the opinion that Petitioner is entitled to entry of the following findings and orders:

Findings of Fact. The Board of Disciplinary Appeals finds that:

- (1) Respondent, John F. McKay, is an attorney who is presently enrolled with the State Bar of Texas but is currently not authorized to practice law in the State of Texas, and whose State Bar Card No. is 00790173;
- (2) On December 12, 2003, in *Case No. 2003-B-3093, styled: In Re: John F. McKay*, the Supreme Court of Louisiana ordered that the Petition for Consent Discipline be accepted and that John Franklin McKay be publicly reprimanded.
- (3) Respondent, John F. McKay, is the same person as the John F. McKay who is the subject before the Supreme Court of Louisiana for having committed misconduct; and

(4) The Decision from the Supreme Court of Louisiana is final.

Conclusions of Law. Based upon the foregoing findings of facts the Board of Disciplinary Appeals makes the following conclusions of law:

- (1) This Board has jurisdiction to hear and determine this matter. Rule 7.08(H), Texas Rules of Disciplinary Procedure;
- (2) Reciprocal discipline identical to that imposed by the Supreme Court of Louisiana is warranted in this case.


It is, accordingly, ORDERED, ADJUDGED, AND DECREED that Respondent, John F. McKay, State Bar Card No. 00790173, is hereby PUBLICLY REPRIMANDED as an attorney at law in the State of Texas.


