**ORDER TO SHOW CAUSE ON  
SECOND AMENDED PETITION FOR RECIPROCAL DISCIPLINE  
AND HEARING NOTICE**

Pursuant to Texas Rules of Disciplinary Procedure (“TRDP”) Part IX, the Commission for Lawyer Discipline, Petitioner, filed its Second Amended Petition for Reciprocal Discipline against Marylin Jenkins Milner, Respondent, on April 9, 2024. The Second Amended Petition states that on July 27, 2023, the District of Columbia Court of Appeals issued an opinion and order in a disciplinary case styled *In Re Marylin Jenkins*, Cause No. 23-BG-0545, in which the court suspended Respondent from the practice of law for thirty (30) days. The court adopted the Report and Recommendation of the Ad Hoc Hearing Committee, finding that Respondent admitted she violated Rule 8.4(c) of the District of Columbia Rules of Professional Conduct. A true and correct copy of the Second Amended Petition for Reciprocal Discipline, which includes the opinion and order of the DC Court of Appeals, is attached hereto and incorporated herein for all purposes as if set forth in full.

It is, therefore, **ORDERED** that Respondent Marylin Jenkins Milner shall, within thirty (30) days from the date of service, show cause why the imposition of identical discipline, to the extent practicable, in Texas by the Board of Disciplinary Appeals pursuant to Texas Rule of Disciplinary Procedure 9.02, would be unwarranted. If Respondent is served by mail, Respondent shall show cause within thirty (30) days from the date of mailing of this Order to Show Cause.

Respondent should consult Part IX of the Texas Rules of Disciplinary Procedure regarding the failure to file an answer. Failure to file a timely answer may waive Respondent's right to raise the defenses set forth in Texas Rule of Disciplinary Procedure 9.04 and limit the scope of the hearing to exclude presentation of any such defenses. *See* TEX. RULES DISCIPLINARY P. R. 9.01–04; BODA INTERNAL PROCEDURAL RULES R. 7.03.

It is further **ORDERED** that this reciprocal discipline matter is set for hearing before the Board on Friday, July 26, 2024, at 9:00 a.m. in the courtroom of the Supreme Court of Texas, Austin, Texas.
