MOTION TO WITHDRAW AS ATTORNEY OF RECORD

TO THE HONORABLE COURT:

COMES NOW Ed Stapleton attorney of record in the above cause, and makes this his Motion to Withdraw as Counsel in the above-styled and numbered causes, and for cause would show as follows:

I.

Withdrawal can be accomplished without material adverse effect on the interests of the client and without unnecessarily delaying the due administration of justice.

Since Ed Stapleton was first retained some three years ago, he has made many changes in his practice. Ed Stapleton has explained to Mr. Ponce that the last three years of aging and illness, Ed Stapleton no longer handles litigation cases outside of Cameron County or anything except criminal defense and appeals.

When the undersigned was retained, Mr. Ponce needed a lawyer quickly and had been unable to retain one in his case. Although this was not Ed Stapleton's usual area of practice, he accepted the case because Mr. Ponce was in immediate need of a lawyer.

Except for some sums defraying travel expenses, no fees have been paid to Ed Stapleton and in recent years, Mr. Ponce, unable to practice law, has been unable to contribute even to travel expenses. Because Ed Stapleton practices in Cameron County, Texas, the cases on which Ed Stapleton has worked for Mr. Ponce have all involved travel.

Mr. Ponce and Ed Stapleton spoke to a lawyer who does most of his work with the Texas State Bar and is in Austin, and if Mr. Ponce hires him, he will be able to handle this case with fewer expenses.

Rehearing of this matter is set for October 28, 2022. Ed Stapleton is scheduled to try a murder case in the 357th on August 15, 2022, and a capital murder case on September 26, 2022. He anticipates the capital case will still be in trial on October 23, 2022, because it requires individual voir dire of the prospective jurors. As a result, Ed Stapleton does not believe he will be available for the upcoming setting.

Ed Stapleton requests leave to withdraw from this case. He has spoken to Mr. Ponce about this matter and by his affixed signature he indicates his agreement.

CERTIFICAT.II OF SERVICE

Continued representation of Mr. Ponce by counsel will result in prejudice to Mr. Ponce in that he will not receive effective assistance of counsel and/or a fair representation in this case because of Ed Stapleton's hectic criminal case load and capital murder/murder trial schedule.
