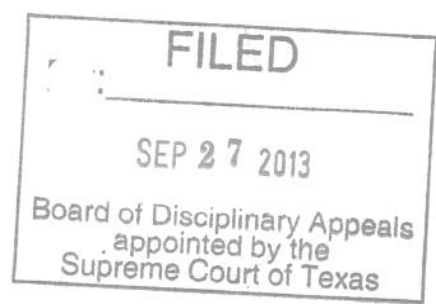

RESPONDENT'S NOTICE OF APPEAL

TO THE HONORABLE BOARD OF DISCIPLINARY APPEALS:

COMES NOW, **CRAIG F. SANDLING, TEX. BAR NO. 17621700** (hereinafter "**Sandling**");¹ complaining of **COMMISSION FOR LAWYER DISCIPLINE** (hereinafter "**CLD**");² AND, gives notice as follows, TO WIT:

A. Notice of Appeal

1. **Decree, Judgment, or Order.** The above-captioned Evidentiary Panel signed the following decrees, judgments, and/or orders, from which **Sandling** desires (see TRAP 25(d)(3)) and intends to appeal (see Tex. R. Disciplinary Proc. 2.24), and actually appeals, as a matter of law. See In the Interest of J.M., 396 S.W.3d 528, 529-31, 56 Tex. Sup. Ct. J. 383 (Tex.: 2013) (*per curiam*) (So long as a timely filed document is filed in a bona fide attempt to invoke appellate jurisdiction, it does so.) and numerous authorities therein cited. TO WIT:

2. **Disbarment.** On July 1st, 2013, the above-captioned Evidentiary Panel signed **Disbarment.** See **JUDGMENT OF DISBARMENT** (Signed July 1st, 2013.).

3. **Order Denying First Motion to Modify.** On July 31st, 2013, in disposition of **RESPONDENT'S FIRST MOTION TO MODIFY (FREEDOM OF CONTRACT)** (Filed July 29th, 2013.), the Evidentiary Panel signed **Order Denying First Motion to Modify.** See **ORDER ON RESPONDENT'S FIRST MOTION TO MODIFY** (Signed July 31st, 2013.).

4. **Order Denying Motion for New Trial.** On August 7th, 2013, in disposition of RESPONDENT'S MOTION FOR NEW TRIAL (Filed July 31st, 2013.), the Evidentiary Panel signed Order Denying Motion for New Trial. See ORDER ON RESPONDENT'S MOTION FOR NEW TRAIL (Signed August 7th, 2013.).

5. **Order Denying Second Motion to Modify.** On August 7th, 2013, in disposition of RESPONDENT'S SECOND MOTION TO MODIFY (DISCRIMINATORY ENFORCEMENT & SELECTIVE PROSECUTION) (Filed July 31st, 2013.), the Evidentiary Panel signed Order Denying Second Motion to Modify. See ORDER ON RESPONDENT'S SECOND MOTION TO MODIFY (Signed August 7th, 2013.).

6. **Order Denying Reconsideration.** On August 20th, 2013, in disposition of MOTION FOR RECONSIDERATION OF THE ORDER DENYING RESPONDENT'S SECOND MOTION TO MODIFY (DISCRIMINATORY ENFORCEMENT & SELECTIVE PROSECUTION) (Filed August 15th, 2013.), the Evidentiary Panel signed Order Denying Second Motion to Modify. See ORDER ON RESPONDENT'S SECOND MOTION TO MODIFY [*sic*] (Signed August 20th, 2013.).

7. **Any- & Everything Else.** This Notice is equally effective to appeal from every other decree, judgment, and/or order (including any underlying issues) that the foregoing decrees, orders, and/or judgments may bring up for review. See Webb v. Jorns, 488 S.W.2d 407, 409, 16 Tex. Sup. Ct. J. 75 (Tex. 1972) (unanimous) (Appeal from final decree, judgment, or order brings up the entire case, including previous interlocutory orders.) and authorities therein cited; Basham v. Smith, 149 Tex. 279, 233 S.W.2d 297, 299, 1950 Tex. LEXIS 457 (Tex. 1950) (unanimous) (Appeal from order disposing of post-judgment motion generally brings up the order assailed in said motion.).

8. **Timeliness.** Sandling files this Notice within NINETY (90) days from the signing of Disbarment, considering that post-judgment motions for new trial and to modify were filed. See Tex. R. Disciplinary Proc. 2.24.
